Awards	All 14 & under events will receive medals for 1st through 8th place for individual events.
Eligibility	Open to all <u>invited</u> registered PVS athletes and <u>invited</u> USA athletes who meet the established NST Qualifying Times.

	<p>The Qualifying Time Period is April 1, 2010 thru the entry deadline. Host team may bring in additional 12 & Under swimmers who do not meet the qualifying times to help with meet volunteer work force.</p>
Rules	<p>The meet will be capped at approx. 3,200 entries.</p> <p>Current USA Swimming rules shall govern the meet. A contestant may participate in only his or her own age group events or in open events which are open to all ages. <u>Contestants may enter a maximum of seven (7) individual events with no more than three (3) individual events per day.</u> Swimmers shall compete at the age attained on the first day of the meet.</p> <p>Fly over starts will be used during prelims.</p> <p><u>Meet Manager reserves the right to Positive Check-In all 50 & 100 meter events in the interest of manageable time lines.</u></p> <p><u>Meet Manager also reserves the right to adjust warm-up times for the 12 & Under sessions and Friday's Distance session after entries have come in.</u></p> <p>Individual Events</p> <p>All 10&U and 11-12 events are timed finals.</p> <p>The 14&U and Open 400 Free and 13-14 & Open 400 IM are Timed Finals and will swim fastest to slowest.</p> <p>All 13-14 and Open individual events will have a "B" final and an "A" final heat. The "B" final for all events will be swum first.</p> <p>All events 200 meters and longer require positive check-in.</p> <p>Yard times will be the conforming times for this meet. LCM times will be seeded after SCY times.</p> <p>No on-deck USA-S registration will be permitted.</p> <p>In compliance with USA Swimming Rules and Regulations; the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy; the use of equipment capable of taking pictures (i.e. cell phones, cameras, PDA's etc) are banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.</p> <p>The practice of deck changing is prohibited at all PVS Sanctioned events. Swimmers participating in deck changing would be violating the USA Swimming Sportsmanship policy</p> <p>Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When</p>

	<p>unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</p> <p>The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 & U events per Rule 205.3.1F.</p>
Relay Events	There are no relays at this meet.
Warm-up / Cool-Down	There is no warm-up / cool-down water available however, two 10 minute breaks will be scheduled in the middle of each session for warm-up / cool-down.
Inclusion Policy for Swimmers with a Disability	PVS and host clubs along with their Meet Directors are committed to the Inclusion Policy as adopted by the BOD . Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.
Time Trials	There will be no time trials conducted at this meet.
PVS Check-in Policy	For those events requiring positive check-in, athletes shall designate their intention to swim the event on the forms provided at the scratch table. Athletes who have not checked-in prior to the specified time will be scratched from the event. Athletes who have checked-in, have been seeded, and fail to swim the event will be barred from their next scheduled individual event, unless excused by the Referee.
PVS Scratch Policy	<p>If you do not wish to swim in the Final, you may "Scratch" from the event by following the proper procedure:</p> <p>You must fill out and sign a PVS Finals Scratch Slip within 30 minutes of the announcement of qualifiers for "A" finals or "B" finals, if scheduled.</p> <p>You may declare an "Intent to Scratch". You must fill out and sign a PVS Finals Scratch Slip within 30 minutes of the announcement of qualifiers, marking the appropriate space for "intent." You must rescind or "pull" this intent on the PVS Finals Scratch Slip within 30 minutes after the conclusion of your last preliminary event of the day or you will be automatically seeded into the event.</p> <p>If an athlete fails to properly scratch from an event and does not appear for the Final event, they "shall be barred from further competition for the remainder of the meet".</p>

Warm-Up	The prescribed Potomac Valley Swimming warm-up procedures and safety policies will be followed. The meet director may determine the structure of the warm-up, including times and lane assignments.
Supervision	Coaches are responsible for the conduct of their Swimmers and Families and for cleaning up their team areas. Only athletes, USA Swimming certified coaches, and deck officials are permitted on the pool deck. Working Coaches & deck officials are required to display

	their 2012 USA Swimming card. Parents not working the meet as a deck official, volunteer lane timer, or other meet position are not permitted on deck.
Admission	There is no admission charge.
Concessions	Concessions will be provided throughout the entire meet.
Programs	Meet programs will be available for \$3.00 per session. Finals programs will be free of charge while supplies last.

Seating	Due to the limited pool deck space, Officials, USA Swimming Registered Coaches and Swimmers only will be permitted on the pool deck.
Warning	Any club or individual that enters an unregistered athlete, falsifies an entry in any way, or permits an unregistered swimmer to represent them, will be fined by PVS the sum of \$100.00 and no further entries will be accepted from that club until the said fine has been paid.
Entries	<p>Entries may be sent via e-mail.</p> <p><u>Short Course entry times are considered conforming times for this meet and will be seeded a head of LC entry times. Include with your commlink file one (1) report by name. Create this report in Team Manager and save as Word for Windows files. <u>You must also check the box for "proof of time"</u> 3. Meet Directors are requested to acknowledge receipt by return e-mail within 24 hours.
