Eligibility: **Open to INVITED TEAMS ONLY.**

TUESDAY, FEBRUARY 5TH, 2013**

Important: The above date is the deadline for clubs to submit their entries to the Meet Director. Therefore, clubs usually set an earlier deadline to receive entries from their swimmers. Check with your club for this information.

Rules: Current USA Swimming rules shall govern the meet. Clubs wishing to be invited need to contact the meet manager.

IMPORTANT: 14 & Under swimmer who attain a new age group between February 17th and March 14th may compete in any event where their time (1) is faster than the 14 & Under JO Qualifier “No Faster Than” standard for their current age group and also (2) slower than the PVS Junior Olympic “No Slower Than” standard for their new age group. This is to permit those swimmers who will be in a new age group at the PVS Junior Olympic Meet an opportunity to qualify.

A contestant may participate in only his or her own age group events or in 14 & under events.

Contestants must have equaled or be slower than the applicable qualifying times listed (no faster than times).

A contestant may enter a maximum of eight (8) individual events. No more than three (3) individual events per day plus one (1) bonus event of 500 Free and 400 IM. Swimmers shall compete at the age attained on the first day of the meet.

“No recall” procedures will be used at this meet.

Dive-over starts will be used at this meet. Coaches are requested to review Guidance for Dive-Over Starts for Coaches. Officials are requested to review Protocol for Dive-Over Starts.

No on-deck USA-S registrations permitted.

In compliance with USA Swimming Rules and Regulations, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker room. As per

PVS policy; the use of equipment capable of taking pictures (i.e. cell phones, cameras, PDA's, etc.) are banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.

Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or swimmer's legal guardian to ensure compliance with this requirement.

Meet Manager reserves the right to Positive Check-in all 200 yard events in the interest of manageable time lines.

Meet Manager also reserves the right to adjust warm-up times for all the sessions after entries have come in.

400 IM & 500 Free require positive check-in.

Entries in 400 IM & 500 Free may need to be limited due to time constraints. If necessary, it will be done based on the verifiable proof of entry trim. If a swimmer is removed from an event because of time constraints, they will be provided the opportunity to enter another event in the meet.

The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 & Under events per Rule 205.3.1F.

Inclusion Policy: PVS and host clubs along with their Meet Directors are committed to the Inclusion Policy as adopted by the BOD. Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or athlete's coach) is also responsible for notifying the session referee of any disability prior to competition.

Time Trials: There will be no time trials conducted at this meet.

Supervision: Coaches are responsible for the conduct of their swimmers and families and for cleaning up their team areas.

Only athletes, USA Swimming certified coaches and deck officials are permitted on the pool deck. Working coaches and deck officials are required to display their 2012 or 2013 USA Swimming card.

Parents not working the meet as a deck official, volunteer lane timer or other meet positions are not permitted on deck.

Admission: There is no admission charge.

Programs: Meet programs will be available for \$2.00 per session.

Awards: There will be awards for this meet.

Seating: Due to the limited pool deck space, officials, USA Swimming registered coaches and swimmers only will be permitted on the pool deck.

Personal chairs will be permitted on the deck for coaches only.

Swimmers will not be permitted to bring chairs on the deck.

Warning: Any club or individual that enters an unregistered athlete, falsifies an entry in any way, or permits an unregistered swimmer to represent them, will be fined by PVS the sum of \$100.00 and no further entries will be accepted from that club until the said fine has been paid.

Entry file: Include in the subject of the email, "Machine JO Qualifier****" with the club's initials in place of the asterisks. Also, include training site if your club submits multiple entry files.

Meet Directors are requested to acknowledge receipt by return email within 24 hours. If acknowledgment is not received in a timely manner, please contact the meet director.

Any club that enters an unregistered or improperly registered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them, will be fined the sum of \$100 and no further entries will be accepted from that club until the said fine is paid.

If time permits, deck entries will be accepted for \$10.00.

Fees: Fees for individual events are **\$5.00 per event.**

Entry fees are due with entries.
