TIMING	Automatic timing will be used
ELIGIBILITY:	Open to all Potomac Valley registered athletes. A swimmers age will be determined as of February 8 th . Athletes may enter a maximum of 5 events.
RULES:	<p>Current USA Swimming rules shall govern the meet.</p> <p>In compliance with USA Swimming Rules and Regulations; the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy; the use of equipment capable of taking pictures (i.e. cell phones, cameras, PDA’s etc) are banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.</p> <p>Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement.</p> <p>Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.</p> <p>The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 & U events per Rule 205.3.1F.</p>
INCLUSION POLICY FOR SWIMERS WITH A DISABILITY:	PVS and host clubs along with their Meet Directors are committed to the Inclusion Policy as adopted by the BOD . Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete’s coach) is

	also responsible for notifying the referee.
SUPERVISION:	Coaches are responsible for the conduct of their swimmers, and should help clean up their respective team area.
WARM-UP:	Potomac Valley Swimming warm-up procedures and safety policies will be followed.
