In applying for this sanction, the Host, All Star Aquatics, agrees to comply and to enforce all health and safety mandates and guidelines of USA Swimming, Potomac Valley Swimming, the State of Maryland, Montgomery County, and Stone Ridge School of the Sacred Heart.

Local Protocols and Requirements

All local and state protocols will be followed per [Montgomery County Phase 2 Guidelines](#). This guidance includes:

- Face coverings required
- Gatherings are limited to 1 person or household per 200 sq. ft. or a maximum of 50 people, whichever number is lower; and the size of the location and venue must accommodate applicable social distancing for the number of attendees.
- 6' spacing on pool deck and spectator area between persons who are not members of the same household
- Prior to facility entry, all attendees will receive a touch-less temperature screening. Per CDC guidelines, individuals with a body temperature greater than 100.4 degrees will not be permitted entry into the facility.

- Children may remove masks whenever they are engaged in vigorous activity

Meet Specific COVID-19 Protocols

- The following health questionnaire must be filled out by October 22nd or entry into the facility will be denied.

- Parents must adhere to following ASA Swim Meet (SR Campus) Protocols:

- Athletes will wear masks when entering and exiting facilities, on deck and during dryland activities.
- All coaches, officials, and volunteers must wear face shields in addition to a face mask. The faces shields will be provided by the host club.
- Athletes must arrive and depart in their swimsuits. Athletes will not be permitted to change or shower at the facility.
- Athletes should arrive 10 minutes prior to their scheduled warm-up times. If athletes arrive early, they must wait in their car until time to enter the facility. **Coaches will wave swimmers in.** Athletes must depart the facility immediately upon the completion of their race(s).
- Once athletes enter the building, they will go to their designated spots and await instructions from their coaches
- There will be 32 marked spaces on the pool deck. Athletes are to remain seated until their heat is called.
 - There will be 1 heat behind the blocks and a second heat 6' behind.
 - Once the next event begins, the third heat will lineup.

After finishing their event, athletes will swim a 25 and climb out at the far side of the pool.

- Athletes should bring 1 full water bottle to each meet.
- Athletes should bring their own folding chair.
- Each swimmer and/or his or her parents is responsible for cleaning and sanitizing his/her belongings before arriving at the facility.
