	• Any swimmer not following the meet protocols will be subject to immediate removal from the meet.		
	• We request that all attendees notify the meet director as soon as possible if they have tested positive for COVID-19, shown symptoms or have been in contact with anyone exposed to COVID-19 after attending the meet.

RULES	Current USA Swimming rules shall govern this meet.		
	• All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming <u>Minor Athlete Abuse Prevention Policy</u> ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.		
	No on-deck USA Swimming registration is permitted.		
	• In compliance with USA Swimming Rules and Regulations, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms, or locker rooms. Per PVS policy, the use of equipment capable of taking pictures (e.g., cell phones, cameras, etc.) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.		
	Deck changes are prohibited.		
	• Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.		
	• Operation of a drone or any other flying devices is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.		
	• Dive-over starts will be used.		
	• The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 & U events per Rule 205.3.1F.		
EVENT RULES	All events are timed finals.		
	• Seed times are long course meters. If long course meter times are not available, coaches' times are preferred over "no times" for all events.		
	• Athletes my enter up to three (3) events.		
	• Deck entries will be accepted if the meet is not over-subscribed. All deck entries must be submitted no later than 45 minutes prior to first event of each session.		
	• Evidence of current USA Swimming registration required for deck entries.		
POSITIVE CHECK	• There will be positive check in for events 400M and longer. The check in will be due 30 minutes before		
IN	the start of events. The Meet Director will determine if additional events will require positive check in.		
	• Athletes who check into a positive check-in event, have been seeded and fail to swim the event will be		
WARM-UP	barred from their next scheduled individual event, unless excused by the Meet Referee.		
	• The prescribed PVS warm-up procedures and safety policies will be followed. The Meet Director will determine the structure of warm-up, including times/lane assignments based upon the number of swimmers per session to accommodate the appropriate number of swimmers per lane.		
SUPERVISION	<ul> <li>Coaches are responsible for the conduct of their swimmers and cleaning up for their team areas.</li> </ul>
