Participation Requirements for PVS Travel Assistance: The meet participation requirements to receive PVS travel assistance

Motion #1:

- 4 swims in PVS sanctioned meets - after April 1, 2011 – entry due date of meet with no requirement to swim the individual event in a PVS sanctioned meet which is swum at the National meet for which travel assistant is being requested. No Double Dipping.
- Funding at \$250 per swimmer (Jr. Nationals) with a cap of \$8,000 total.
- Funding at \$450 per swimmer (Sr. Nationals) with a cap of \$11,700 total.

PVS Travel Assistance for 2012 Olympic Team Trials

June 25-July 2 - Omaha, NE

Participation Requirements for PVS Travel Assistance: The meet participation requirements to receive PVS travel assistance

Motion #2:

- 2012 USA Olympic Trials – 6 swims in PVS sanctioned meets from at least 2 meets – after 9/1/11 and prior to entry due date of meet with no requirement to swim the individual event in a PVS sanctioned meet which is swum at the National meet for which travel assistant is being requested. No Double Dipping.
- 2012 US Paralympics Trials – 6 swims in PVS sanctioned meets from at least 2 meets – after 9/1/11 and prior to due date of meet with no requirement to swim the individual event in a PVS sanctioned meet which is swum at the National meet for which travel assistant is being requested.
 - Funding of \$600 per athlete w/Cap of 1,200 for US Paralympic Trials
 - Funding of \$800 per athlete w/ no cap.
 - Time Trials to qualify in calculating required swims.

August 7-11, 2012 – Indianapolis, IN

Motion #3:

- 4 swims in PVS sanctioned meets - after April 1, 2011 – entry due date of meet with no requirement to swim the individual event in a PVS sanctioned meet which is swum at the National meet for which travel assistant is being requested. No Double Dipping.
- Funding at \$250 per swimmer with a cap of \$3,750 total.

- 4 swims in PVS sanctioned meets - after April 1, 2011 – entry due date of meet with no requirement to swim the individual event in a PVS sanctioned meet which is swum at the National meet for which travel assistant is being requested. No Double Dipping.
- Funding at \$250 per swimmer with a cap of \$7,500 total.
