## **Policy & Procedures Manual**

## **Paralympians**

2 PVS athletes participated in the 2019 World Para Swimming Championships, September, 2019 in London: Lawrence Sapp (S14) and Becca Meyers (S12 & S13). Lawrence won silver in the 100M Butterfly. Becca won gold in the 400M Freestyle, silver in the 200M IM, and bronze in the 100M Freestyle and 100M Butterfly; in the process, she set 2 World records and 5 American records.

### **Minimum Number of Officials**

17 PVS clubs were recently notified that they failed to meet the requirement for a minimum number of officials. Due to the sudden curtailment of the competition season, the fines were waived by the Board for this year. But all clubs are reminded of this requirement, and are encouraged to step-up their efforts in recruiting and retaining officials.

PVS relies on its clubs to encourage parents to become deck officials—it's a <u>very</u> positive way for parents to become involved with swimming. The PVS Officials Committee and USA Swimming have a variety of resources available to assist in recruiting and retaining officials. Many in-person and online clinics are offered throughout the year.
