Officials Committee Report to the PVS House of Delegates

The Officials Committee is authorized and obligated to recruit, train, test, certify, evaluate, retest, recertify, and supervise officials for PVS.

The Officials Committee is responsible for staffing of the two Senior Championship meets, the Junior Olympic meet, and any other PVS sponsored meet in which participating officials may obtain USA Swimming National Certification.

Training, Certification, Re-Certification

The PVS Officials' Corps is slowly rebuilding. The PVS Officials Committee has supported virtual clinics since the beginning of the pandemic, including the following clinics from April 1, 2021 – March 31, 2022:

6 Stroke & Turn Clinics; 286 attendees

4 Administrative Official Clinics; 43 attendees

4 Chief Judge Clinics; 63 attendees

1 New Referee Clinic; 2 attendees

4 Starter Clinics; 76 attendees

1 Referee Clinic; 24 attendees

Officials Education Travel Stipend

PVS offers an Officials Education Travel Stipend for officials who officiate at Zone, Sectional, Futures, Tyr Pro and National meets. To date, PVS has provided stipend for 17 officials who supported eligible meets from April 1, 2021 – March 31, 2022. Additional requests are anticipated. PVS also provided a travel stipend to 6 officials who supported Olympic Trials.

PVS-Paid Officials USA Swimming Membership

Normally, PVS pays for the re-registration of officials who officiate a minimum of ten sessions during the previous calendar year. Due to the pandemic, the minimum number of sessions was reduced to 6. 290 PVS Officials qualified for this benefit. To date, PVS has paid for the 2022 USA Swimming registration for 268 PVS Officials.
