# • Meet Management Proposal & Timer Requirements

### Discussion

- T. Husson & M. Rubin provided status of proposal.
- The officials committee understands that the proposal was not adopted by the BOD because: (1) concern about the specific number of staff specified in the proposal (specifically two admin support persons) and (2) the Board's feeling that current PVS Policies and Procedures cover the consequences of clubs not providing adequate staffing. The Board felt that the issue could be better addressed in the new meet director's handbook, which is under development.
- The officials committee noted that the current PVS Policies and Procedures do not define what "adequate staffing" is. Without this definition and a clear statement of the consequences of not complying, the Officials Committee remains concerned that some meet directors will not supply adequate personnel including timing personnel as required by 102.9.

### Place Judges at PVS Meet

### Discussion

- Current rules require Place Judges
- Place Judges should be part of relief rotation.
- Staffing for meets should account for 2 Starters per session to support use of Place Judges.
- Stress in Starter training on the importance of OOF.
- Stress at Referee Clinic the importance of Place Judges.

### Decision

- The committee generally recommends against the use of stroke and turn judges as place judges. This is for two reasons: (1) stroke and turn judges who are not certified as starters may not be accustomed to quickly identifying lanes, (2) only recording order of finish for an entire session could become mundane. In the rare cases where a S&T official is used as a place judge, adequate relief should be provided.
- Committee recommends use of two Starters per session. Off-starter should take OOF. If two Starters are not available, the Starter should record the order of finish as best as possible, with assistance from the Deck Referee or other officials if necessary.

### Background check
