### USA Swimming Quarterly Conference Call

#### Discussion

- OTS Some LSC are not using. PVS is one of the LSC that make extensive use of OTS. Some new administrative reports are available.
- Admin Official Discussed new position. Discussions on the call indicate that PVS thinking on this new position is in-line with USA Swimming intent.
- Deck Changing Guidance is to warn the athlete to stop; involve the coach; disciplinary action is warranted only if it is a repeat offense or if the athlete refuses to comply.
- Certification Many LSCs reporting confusion among officials regarding certification/registration procedures. According to the rulebook, there are four requirements to serve on deck as an official: LSC Certification (Article 102.10.2); USA Swimming Membership (Article 202.3.3); Criminal Background Check (Article 502.6.1, Article 502.6.3); Athlete Protection Training Course (Article 502.6.1, Article 502.6.3
- Grand Prix Meets USA Swimming raising the profile of these meets, with significant prize money and higher officiating standards.
- Officials Training Rather than producing another training CD, the thought is to provide short online video segments on different strokes and aspects of officiating that will be readily accessible and can easily be modified if rules/interpretations change.
- Conference call is a good opportunity to get consistency across the country.

requirements for PVS clubs provided they hold current USA Swimming membership. USA Swimming membership will allow tracking table officials in OTS.

- Committee discussed requirements for PVS to pay USA Swimming membership for working officials. Currently a document does not exist that articulates the requirements. Committee discussed number of sessions and time period.
- At discretion of the Officials Chair may decide on a grace period for expired certifications on case-by-case basis.

### Decision

- Committee concurred on the following:
  - Table officials can be counted as part of the officials requirements for a PVS club provided they are registered with USA Swimming and can be tracked through OTS.
  - An official must work ten sessions in a calendar year for PVS to pay for the official's USA Swimming registration.

- B. Vincent reported on travel reimbursement procedures for the lead evaluator at the Sport Fair Winter Invitational and suggested that the Committee review its policies for reimbursing evaluators.

### Clinics Update

- S. Edwards reported on clinic attendance. To-date 236 officials for initial certification and 64 officials for recertification.
- Revised cover sheets for recertification form.
- Propose to increase time for clinics from 2 hours to 2.5 hours.
