 - AG Champs large attendance. Last 3 years meet have grown even though cut times have been reduced.
 - PVS Junior and Senior Champs went to 4 full days. Similar attendance numbers. Well run.
 - Super-sectional for the Eastern Zone was moved up two weeks, to mid-July. 100 swimmers attended. Attendance down due to conflict with LSC championship meets. Two Olympic Trial cuts achieved.
 - USA Swimming Futures Meet new meet this season. Initial impression is that the meets were successful. Positive Coach feedback on this meet.
 - Jr National/National meets were well run. Good participation by PVS Officials.
 - Meet Statistics
 - 141 Meets this season in SWIMS. 15 were observed meets. 6 were approved meets (YMCA, Black History). Record number of Dual/Intra-squad meets this past season (23).
 - Officials Statistics
 - 542 certified officials on roster. Compared to last season (556 officials) down by 14. Most of the decrease is due to cleaning up of old data. Currently 75 Referees on the roster.
 - o Anecdotal comments indicate meets have been well staffed.
