Recap of 2015-2016 Season

Discussion

- LC Season Review Age Group Champs had faster qualifying times, but ended up with about 1200 swimmers.
- Junior and Senior Champs were about the same size as last year. Moved from three-day format to four-day last year. Converted from National Scratch procedure to all positive check-in. This worked out well.
- The Future Meets about the right size. Futures Meet at College Park was well run. Good staffing, especially in Timers.
- Meet Statistics: last season 157 meets, 19 were observed meets, six were approved meets, 19 dual/tri meets.
- Officials: 576 officials, most ever registered. 82 are Referees about 15%. 144 officials have N2 or N3 certification. PVS percentage of N2/N3 higher than some other large LSCs.

• Clinic Schedule
