OFFICIALS CHAIR

- Officials Chair highlighted some of the communications that he intended to send out and did
 not get accomplished since the last officials committee meeting. The goal is to get these
 communications out the applicable group of PVS officials before the August 2018 officials
 committee meeting.
- Additionally, the chair has not followed through with the PVS athlete representative(s) to discuss obtaining athlete representation on the officials committee.
- Officials Chair will send the most recent New and Re-certifying Deck Referee presentations to the Training and Evaluation Sub-committee so they can standardize the referee content/presentations.

OFFICIALS COMMITTEE

- Barbara Chambers accepted the invitation to be the lead National Evaluator for the NCAP Invitational 6-9 December 2018.
- Discussion of the Spring Officials Social indicated that it was a fun and positive experience for those in attendance. The committee is looking for a venue in Maryland for the Spring 2019 iteration and is open to suggestions.
- The OC discussed meet staffing, to date, for the 2018 LC season. The general perception is that there are lower numbers of officials at the LC meets than in recent memory. Numerous theories were floated and the officials chair is asking the administrative sub-committee to do a year by year comparison of LC meets and numbers of officials in attendance. After reviewing the data from the administrative sub-committee, the officials chair will work through the Operations Vice-Chair to present concerns to the PVS BOD, if the numbers indicate an issue.
- Dave DiNardo, in his role as the Chair of the PVS Strategic Planning Committee is looking for more "officials" representation on that committee. David Merkin volunteered to assist the Strategic Planning Committee and Dave DiNardo agreed to craft an e-mail that would go out to all or a tailored group of PVS officials, seeking those interested in serving with/on the Strategic Planning Committee.

TRAINING and EVALUATION SUBCOMMITTEE (Jack Neill, Chair)

• Review of Clinic Presenters/Evaluators: The OC reviewed and voted on 4 submissions to

become clinic presenters and evaluators. Results will be combined and sent to the PVS

webmaster, so that the evaluator lists can be amended. PVS officials can apply to be

evaluators/clinic presenters at any time, and their applications will be reviewed at the next
