Important Holidays to Watch

November has some important dates to remember. Be prepared to provide educational opportunities about these important holidays.

- **November 14-20:** Child Safety Week
- **November 19:** Word Day for the Prevention of Child Abuse

Below are some tips and resources you can use to provide an educational opportunity within your club or LSC:

- Make sure everyone has the U.S. Center for SafeSport's updated reporting number. It is **1-833-5US-SAFE (587-7233)**.
- Review the new [Guide to Child Physical Abuse](#).
- Start working on the [Safe Sport Club Recognition](#) program with your club.
- Bring continued attention to the mandatory [Minor Athlete Abuse Prevention Policy](#) by having conversations about the program, utilizing example consent forms and confirming your club is using the updated MAAPP 2.0 policy.

- Confirm all athletes 18 years old and above have taken the [Athlete Protection Training](#) so they can participate in all USA Swimming sanctioned meets this year.
- Download Activity Books for [5-11 year olds](#) or [12-18 year olds](#) to complete.
- Encourage athletes, parents and coaches to attend the [SSRP trainings](#) before the end of the year.
- Request a USA Swimming [Safe Sport Speaker](#) to talk to your club or LSC.

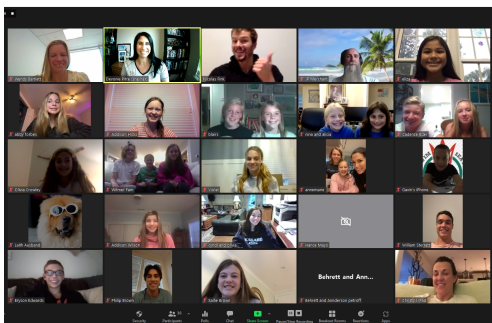
SSRP Spotlight

MAAPP 2.0

The deadline to implement MAAPP 2.0 was September 1, 2021.

This is a requirement for all USA Swimming members, its member clubs, LSCs and Zones. In addition, all members must review and sign this policy annually.

2021 SSRP Trainings

Safe Sport is committed to creating a healthy environment that is free from abuse for all members. As we continue with virtual learning opportunities throughout 2021, we will be increasing security measures to keep parents, athletes and coaches safe during trainings. **All trainings will require individuals to register ahead of time.**

In addition, we have enhanced our Safe Sport Trainings' security measures and will have the following in place:

- Meetings will be locked
- Athlete attendees will only have access to chat with hosts
- Multiple USA Swimming Safe Sport staff will be on all trainings and will monitor participant video share
- Frequent check-ins with attendees
- Screen share and annotation capabilities will be disabled
- Meetings will require registration and athlete training registrations will be cross-checked with USA Swimming member records
- USA Swimming has enabled the At-Risk Meeting Notifier tool from Zoom. This tool searches the public internet for Zoom meeting information and checks the meeting's security settings. Zoom notifies USA Swimming if a meeting appears to be at high risk for being disrupted. This tool is enabled for all USA Swimming hosted Zoom meetings.

Membership Extension from 9/1/21 to 1/1/22

On July 15, 2021, you received a communication announcing all employees and individuals serving on the board of directors of USA Swimming Zones, Local Swimming Committees (LSCs) and member clubs must be non-athlete members of USA Swimming. Since then, we have received numerous inquiries about how this requirement applies to institutionally-owned clubs. USA Swimming has been working with the U.S. Center for SafeSport in an attempt to be able to provide guidance to institutionally-owned clubs. To date, we continue this effort but do not have full guidance to provide.

As a result, USA Swimming is **extending the implementation date of this requirement to January 1, 2022**. We anticipate being able to provide full guidance to clubs, LSCs and members in advance of this new deadline. Please look forward to receiving further communications from USA Swimming on this matter.

Please note, all individuals who have direct and frequent contact with, or who have authority over, athletes are required to be non-athlete members of USA Swimming. For any questions or concerns, please contact safesport@usaswimming.org.
